The Parties hereby agree to the following:

Article 1

The two aforesaid Parties wish to establish cooperation in all academic areas of mutual interest, e.g.: joint activities for the education of students and doctoral students, research, academic exchange of students and staff, administrative management, etc.

Article 2

The Parties shall establish a schedule for the joint tasks under this Memorandum of Understanding (hereinafter referred to as "the schedule"), together with a time limit for their completion and the person responsible for the implementation of each task. The schedule constitutes Annex No 1 to this Memorandum of Understanding.

Article 3

The following persons are responsible for the implementation of the Memorandum of Understanding:

Article 4

Any specific activity shall be the subject of mutual consent and approval of both Parties. The detailed terms of such activity shall be discussed and agreed upon in writing, by the Deans of the cooperating faculties, and signed by the two aforesaid Coordinators of both Universities before the initiation of any particular programme of activity, with reference to this Memorandum of Understanding.

Article 5

This Memorandum of Understanding is valid for an initial duration of two years and shall take immediate effect upon signature by the two Parties. Either Party may request changes to and/or cancellation of this Memorandum of Understanding by giving six months' prior notice. In that case, the actions in hand shall be brought to completion.

Article 6

The Parties agree to place information about this Memorandum of Understanding on their websites and in promotional materials along with the permission to use the logo of the Partner for the promotion of this cooperation.

Article 7

This Memorandum of Understanding is made in English in two identical copies, each copy being deemed authentic. Each Party shall receive a copy.
